IMAGin® PrintVinyl Scored PVS528P

Product Description

PVS528P is a 3.2-mil **Matte** white, soft-calendared PVC film designed for wide format printing. The product is coated on one side with a permanent, **Clear** acrylic pressure sensitive adhesive and supplied with a 78# bleached kraft lay flat liner that is back scored 1.25" apart across the width.

PVS528P, is designed for applications where an easy to remove liner is beneficial to the end user such as labels and decals, point of purchase graphics, bumper strips and other identification pieces.

Durability

The indoor durability of this film is 5 years and the outdoor durability of the unprinted film is 6 years. Over lamination of the inkjet-printed material with PERMACOLOR® or IMAGin overlaminates delays color fading that may occur over time. This color fading is mainly dependent upon the inks quality (see technical data sheets given by the ink manufacturers) and the pressure sensitive media being used.

Shelf Life

2 years from D.O.M. when stored at 60/77°F (15/25°C) and 50% relative humidity in the original package.

Limitations

Due to the wide variability of interior walls, sealants and paints, no claims for successful applications to or removal from painted wall surfaces are made by MACtac. It is the users' responsibility to determine the products suitability for the intended wall.

- The user is responsible for determining the product's suitability, including adhesion and if needed, removal characteristics when used in applications other than listed specifically in this Performance Guide.

- 4) Installation: Wet application method is not recommended for the installation of this product. The use of application fluids could affect the adhesion strength to the substrate because the adhesive is water based and will soften.

Recommendations

Always test your combination of PRINT VINYL products, inks and laminating films prior to commercial use.

- 1) **Printing Conditions:** Print in conditioned pressroom at ±73°F (23°C) and 50% RH. The maximum allowable ink saturation is 270%.
- 2) **Drying Requirements:** Solvent, Eco-solvent and Mild-solvent inkjet prints require 24 48 hr. drying time open to the air. Inks do not dry when printed media is rolled up. The prints must be dry prior to lamination.
- 3) Laminating Conditions: If the printed graphic is likely to be exposed to corrosive liquids, smoke, fumes, highly polluted areas or there is a likelihood of scratching, it is highly recommended to laminate with PERMACOLOR ColorGard LUV series (Intermediate) or PromoGard (economy) overlaminating films. Please be aware that adding an overlaminate will significantly reduce conformability to complex surfaces.

th by	ransportation Conditions: To allow for easy transportation, PV500 series can be rolled up, with ne image out, with a minimum diameter of 6 inches (15cm). When the image is not protected y an overlaminate, make sure the print is completely dry and protected in a plastic bag. During
